SUMMARY ANNUAL REPORT PLUMBERS AND PIPEFITTERS LOCAL UNION 172 VOLUNTARY 401(k) PLAN

This is a summary of the annual report for the Plumbers and Pipefitters Local Union 172 Voluntary 401(k) Plan, EIN 35-1971399, for the period ended March 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a Trust.

Plan expenses were \$631,570. These expenses included \$93,694 in administrative expenses and \$537,879 in benefits paid to participants. A total of 353 persons were participants in or beneficiaries of the Plan at the end of the plan year.

The value of Plan assets, after subtracting liabilities of the Plan, was \$12,576,492 as of March 31, 2022, compared to \$12,234,563 as of April 1, 2021. During the year, the Plan experienced an increase in its net assets of \$341,929. This increase included unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of the assets acquired during the year. During the Plan Year, the Plan had total income of \$973,499, including employer contributions of \$26,075, participant contributions of \$493,563, rollover contributions of \$1,550, income from investments of \$452,155 and other income of \$156.

The charge to cover copying costs, given above, does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the Plan, 6525 Centurion Drive, Lansing, Michigan, 48917-9275, at any other location where the report is available for examination, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor, upon payment of copying costs.
